

Purpose and Effect

An application to amend the Official Plan and Zoning By-law to permit the development of a 48-storey mixed-use building.

A total number of 549 units are proposed, ranging from one to three bedrooms in size. The proposed development also includes four underground parking levels with a total of 184 space, indoor amenity space, outdoor amenity space, and potential commercial space. This development is being planned to include additional properties immediately south (17-21 Mill Street North) to allow for the phased expansion of the application with a second building similar in scale, use and height. All vehicular access would be shared from the proposed driveway on Mill Street North.

The property is located south of Nelson Street West and west of Mill Street North.


Important Information about making a submission

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Brampton with respect to a proposed Official Plan Amendment or proposed Zoning By-law Amendment before a Zoning By-law is passed, or before a proposed Official Olan Amendment is adopted:

- (a) The person or public body is not entitled to appeal the decision of the City of Brampton to the Local Planning Appeal Tribunal; and,
- (b) The person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
