Downtown Brampton Streetscape Project Queen Street East between Main Street and Theatre Lane

Start Date: September 2024
Expected End Date: December 2024
***New end date: January 2025**
**Timeline is subject to change.*

The Downtown Brampton Streetscape Project has experienced delays in the delivery of the granite pavers. Work will proceed on the north side of Queen Street East between Main Street and Theatre Lane until completion of the installation, starting upon receipt of the granite pavers. Once completed on the north side, the construction zone will shift to the same area on the south side of Queen Street East.

Downtown Brampton Streetscape work will be paused for holidays between December 20, 2024 to January 6, 2025. The work involves widening of existing sidewalks with new granite pavers, narrowing roadways to one lane in each direction and resurfacing the pavement, constructing semi-mountable granite curbs with 1.5m wide bicycle lane, installing new moveable planter, installing new street furniture (i.e., benches) and replacing six traffic signals with new components.

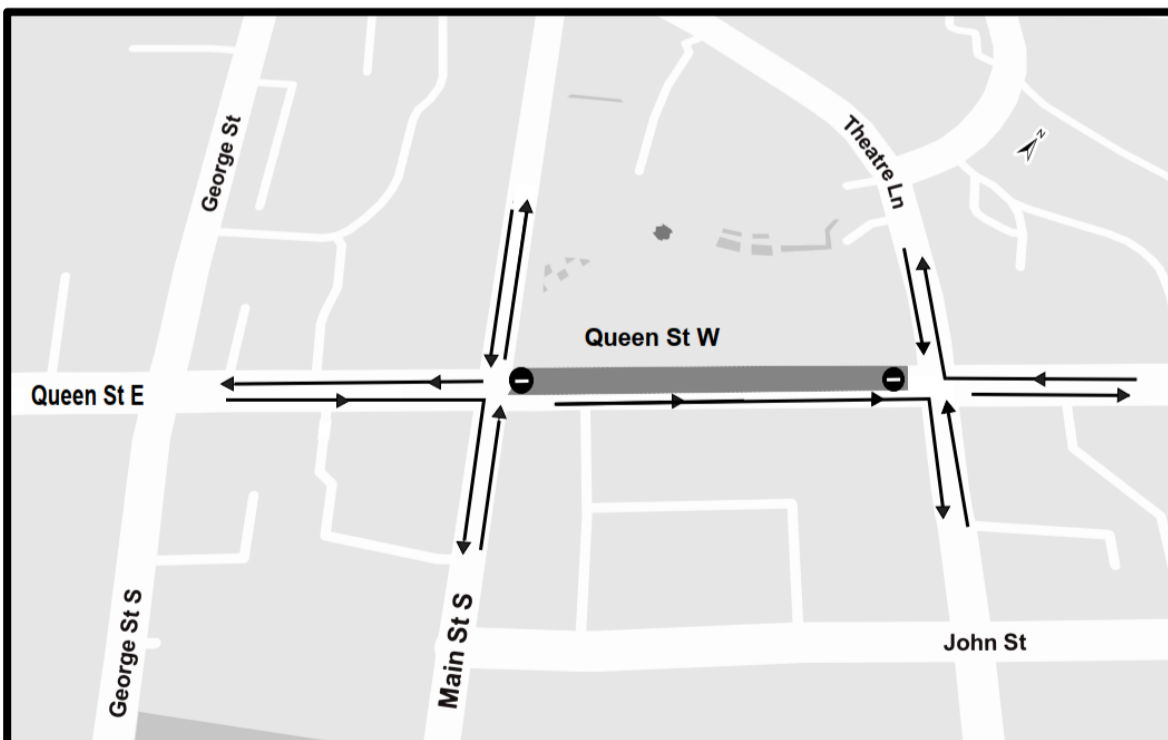
WORK STATUS TO DATE

Sidewalk and bike lane base concrete is complete and ready for the granite pavers. Road base asphalt is complete, allowing the westbound lane of Queen Street East to be open to traffic upon completion of the granite paver installation of sidewalk and bike lane.

REMAINING WORK

- Granite paver installation will continue at the north side of Queen Street East between Main Street and Theatre Lane.
- Installation of underground ladders in maintenance holes on Queen Street East/West from Mill Street to Mary Street, and Main Street North/South from Wellington Street to Nelson Street. Work is being undertaken at various locations within the work zone during both day and night to minimize traffic disruption.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.

	<p>Important information for Business Owners. Property owners should remove items located within City property limits (boulevard) to avoid damage. If you have any concerns about the removal of private items, please contact the Field Ambassador listed below.</p>
	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Traffic Management: Queen Street East west bound lane between Main Street and Theatre Lane will be open to traffic upon completion of the granite paver installation. The east bound lane is scheduled for closure when the work zone shifts to the south side of Queen Street East between Main Street and Theatre Lane.</p>
	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Pedestrians: The work may require temporary sidewalk restrictions, however any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.</p>
	<p>People Cycling: The new section of the bike lane is to be installed on the north side of Queen Street East between Main Street and Theatre Lane upon arrival of the granite pavers.</p>
	<p>Parking: This project will impact on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated.</p> <p>Free municipal parking is available in downtown Brampton. Visit Brampton.ca/parking for a listing.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>
