# Downtown Brampton Streetscape Project Queen Street East between Main Street and Theatre Lane

Start Date: September 2024
Expected End Date: January 2025
\*New end date: end of March 2025
\*Timeline is subject to change.

Work on the Downtown Brampton Streetscape Project is progressing well. Due to the cold weather conditions a 70 ft x 10 ft canopy/scaffolding structure is being used in the work zone. The large canopy will move closer to the Main St & Queen St intersection as it's final location before disassembling. Additionally, two smaller tents will be setup for the same purpose of protecting workers and construction materials during work. They are to be placed flush against the store fronts extending to the border of the newly paved section. The tents will remain in front of each building for about 3 to 5 days before being shifted to the next section. Access to business entrances, pedestrian sidewalks and loading zones will be maintained. There will be short intervals interrupting access to businesses when work is directly in front of doorways. **The Contractor is responsible for maintaining pedestrian access during these intervals and will accommodate upon request.** 

A new end date is rescheduled for the end of March 2025 however dates are subject to change due to winter weather conditions or unforeseen construction issues. Once completed on the north side, the construction zone will shift to the same area on the south side of Queen Street East. The work involves widening of existing sidewalks with new granite pavers, narrowing roadways to one lane in each direction and resurfacing the pavement, constructing semi-mountable granite curbs with 1.5m wide bicycle lane, installing new moveable planters, installing new street furniture (i.e. benches) and replacing six traffic signals with new components. A Construction Impact notice advising the public will be provided prior to the move.


#### **WORK STATUS TO DATE**

## WHAT TO EXPECT DURING CONSTRUCTION

	<b>Work Hours</b> : Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.	
<b>\$</b>	<b>Traffic Management</b> : Queen Street East west bound lane between Main Street and Theatre Lane will be open to traffic upon completion of the granite paver installation. The east bound lane is scheduled for closure when the work zone shifts to the south side of Queen Street East between Main Street and Theatre Lane.	
٤	Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.	
	<b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.	
广	<b>Pedestrians:</b> The work may require temporary sidewalk restrictions, however any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.	
<b>5</b> 0	<b>People Cycling:</b> The new section of the bike lane is to be installed on the north side of Queen Street East between Main Street and Theatre Lane.	
8	<b>Parking:</b> This project will impact on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated.	
	Free municipal parking is available in downtown Brampton. Visit Brampton.ca/parking for a listing.	
Ė	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
